**Education Tax Refund:** The Commonwealth government has introduced The *Education Tax Refund*. The *Education Tax Refund* (ETR) aims to help families, with children undertaking primary or secondary school studies to meet the costs of school education through assistance with certain education expenses.

Under the Government's ETR, eligible families will be able to claim:

- a 50 per cent refundable tax offset every year for up to \$750 for each child undertaking primary school, (that is, a refund of up to \$375 per child, per year);
- a 50 per cent refundable tax offset every year for up to \$1,500 for each child undertaking secondary school (that is, a refund of up to \$750 per child, per year).

To help you claim these benefits, Jubilee Christian College has split its previously all-inclusive fee in order to show certain items that you are able to claim as part of your Education Tax Refund. These will be itemised on your Tax Invoice.

The **Tuition Fee** includes the costs of Home Visits, Activity Days, student registration at camps, Progress Reports, Teacher and Administration assistance.

The **Texts Fee** covers all curriculum material, printing, postage and the use of Literature Books, Resources Books, and Score Keys. Jubilee Christian College maintains a library of Score Keys, literature books, text and resource books for parent's use. They are ordered from the College when a PACE order is placed, and returned when the student has finished with them. This avoids families having to purchase the score keys, etc. and then store or dispose of them.

The **Texts Fee** should be claimable under the governments' *Education Tax Refund*, as well as any expenses you may incur at home including postage, stationery, calculators, supplying your student with a computer, printer and internet connection. (Please consult your accountant or tax agent as to what is claimable)

Please note that you have the option of paying your fees in two payments in February & July to receive a 10% discount, *or* in one payment in February to receive a 20% discount. If you later withdraw your student/s from the College, you will receive a pro-rata refund. The discount is now calculated only on the **Tuition Fee**.
